With reference to your application and subsequent correspondence with the school/inspection in this regard, I convey the grant for recognition The Convent, Jhammat Road, Pohir, Ludhiana, Block Dehlon-1* for Class 1ST TO 8TH CLASS, your school given a self declaration that your school fulfills all the conditions and norms of RTE Act 2009 to see the self declaration given by your school and grant the permanent recognition of your school.

The above sanction is subject to fulfillment of following conditions:-

 The grant for recognition is not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.

The School shall abide by the provisions of Right of Children to Free and Free and Compulsory Education Rules, 2009 (Annexure II).

- The School shall admit in class I, to the extent of 25% of the strength of that class, children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary education till its completion. Provided, further that in case of pre primary classes also, this norm shall be followed.
- For the children referred to in paragraph 3, the School shall be reimbursed as per Section 12(2) of the Act. To receive such reimbursements school shall provide a separate bank account.
- The Society/School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
- The School shall not deny admission
 To any child for lack of age proof.

 If such admission is sought subsequent to the extended provided prescribed for admission.
 - On the ground of religion, caste or race, place of birth or any of them.
- The School shall ensure:
 - No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school;
 - (ii) No child shall be subjected to physical punishment or mental harassment;
 - (iii) No child is required to pass any board examination till the completion of elementary education;
 - (iv) Every child completing elementary education shall be awarded a certificate as laid down under Rule 23
 - (v) Inclusion of Students with disabilities/special needs as per provision of the Act
 - (vi) The teachers are recruited with minimum qualifications as laid under section 23(1) of the Act. Provided further that the current reachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualifications convent.
